Summer Construction Projects



- Paving of Burton Road in collaboration with the City of Ottawa.

- Replacement of a bridge on St-Pierre Road between Route 300 and Route 200. The work will begin after July 15, 2025.

We invite you to participate in the Meet Me on Main Street event on Tuesday, July 15, 2025, from 5 p.m. to 8 p.m. in Russell.



Fast-Track Your Small Residential Projects!

From May 6 to September 2, apply for a 48-hour building permit for small residential projects like decks, sheds, or minor residential renovations.

Submit your application before noon on Mondays. Permits will be issued by Wednesday morning, as long all information is provided, and the proposal complies with the Ontario Building Code and municipal zoning bylaws.

Development Charges Study – Have Your Say!

The Township of Russell is currently undertaking a Development Charges (DC) Study to plan for our community's future growth and ensure that new development continues to contribute its fair share to the infrastructure and services that support our residents.

Development Charges are fees collected from developers to help pay for new roads, parks, water, wastewater systems, and other key services that are needed as our community expands. This study is an important tool that ensures growth is funded in a responsible and sustainable way, helping us maintain the high quality of life that residents expect, without placing an undue burden on existing taxpayers.

As part of this process, we will be hosting public engagement sessions where residents will have the opportunity to learn more about the DC Study, ask questions, and provide feedback. We want to hear your voice and ensure that this plan reflects the priorities and needs of our growing community.

Summer Safety Reminders

As Summer approaches, Russell Township Fire Services and various Township Departments will be out in our community. Please come see us at one of these special events; Embrun Summerfest on June 14, Meet me on Main Street on July 15, and the Russell Fair on August 14-17.

During the summer, we ask all of our residents to pay attention to specific regulations surrounding fire safety within our community. Contact the Public Safety and Enforcement Department when planning special events at bylaws.reglements@russell.ca.

Open Air Burning

All open-air burning requires a fire permit to be issued at least 24 hrs before the start of burning. Permits are \$40 and can obtained in person or by mail at Town Hall.

Fire Bans

Fire bans are implemented when safety conditions are a concern. NO burning is allowed if a fire ban is in effect. It is your responsibility to verify if a fire ban is in place. You can subscribe to receive alerts at *Russell.ca/subscribe*.

Campfires

A permit is not required for recreational campfires but certain rules need to be followed. Your campfire:

- can't be larger than 0.5 cubic meters;
- must be contained and in the backyard only, at least
 4.5 meters from any lot lines and combustible items;
- must be supervised at all times by a person of at least 18 years of age until completely extinguished.

Before lighting up, check for Fire Ban Notices at *Russell.ca/FireBan*.



Fireworks

Consumer fireworks (family fireworks) are not allowed in parks but are allowed on your property between sunset and 11:00 p.m. on the following days:

- The day before, the day of, and the day after St Jean Baptiste.
- Two days before, the day of, and two days after Canada Day.

Make Sure Your Civic Address is Visible

9-1-1 blade signs not only identify the civic address of a property but also play a critical role in helping emergency services quickly locate where assistance is needed—improving response times in urgent situations.

Under the Civic Addressing and 9-1-1 Protocol By-law #116-2014, every property's civic number must be clearly visible from the street, either through a 9-1-1 blade sign or by posting the number directly on the building.

We encourage all property owners to ensure their civic address is clearly marked, especially in case of emergencies. If you believe your address may not be properly identified, please contact the Planning Department at planning@russell.ca.
